Upon applying for Hikone's public housing, please note that you need to meet all the conditions and terms. Please read this information guide prior to applying for public housing.

☆ Application Periods

- On weekends and national holidays, the city does not accept any applications, nor do we provide the necessary application forms.
- Detailed information about available public housing apartments will appear in Hikone City's community newsletter in the same month as the city begins accepting applications.
- o If no vacancies, the city will not accept any applications.
- •With regard to public housing for people under special circumstances, applications become open from time to time.

★Eligibility Criteria

Prior to applying for affordable rental housing in Hikone, each applicant must meet all the following conditions.

- 1. Living or Working in Hikone.
- 2. Having no balance for local taxes such as a resident tax, Kei-car tax, property tax, etc.
- 3. Planning to move into a city-run apartment with a family member(s).
 - *If an applicant wants to rent a city-run apartment and live alone, there are additional conditions to be met.
 - *If an applicant is engaged with a person moving in with him/her and planning to register a marriage within three months, the applicant's soon-to-be spouse can be counted as a family member.
 - *If an applicant's family structure is deemed to be questionable or reasons why your family is living separately are unusual, your application may be turned down.
- 4. Total monthly household income (income of all dependents living separately is included) must be under 158,000 JPY. This monthly income threshold is 214,000 JPY if an applicant's household comprises older members or other special reasons can be applicable. (See page 3)
 - *The calculation methods for the monthly income thresholds are listed from page 7 to 11.
- 5. An applicant's main reason to apply for affordable housing must be at least one the following reasons.
 - (1) Living in a commercial property like a shop, office, etc.
 - (2) Living in an old building that poses dangers due to its aging structure, etc.
 - (3) Sharing a kitchen, toilet, bathroom, or other space of an applicant's current place with other tenants.
 - (4) Inconvenient given an applicant needs to share his/her current place with another/other household(s).
 - (5) Having no place to move into with an applicant's family or engaged person.
 - (6) A current apartment is small. *The size must be smaller than 4.5 Tamami mats per person.
 - (7) An eviction notice has been issued from a landlord/landlady for legitimate reasons, except for any reason attributable to an applicant's fault.
 - (8) Taking more than one hour to commute to work. *An applicant's workplace must be in Hikone.
 - (9) Rent is expensive *An applicant's current rent must account for 25%.
- 6. Not having any balance for a city-run apartment, apartment parking space, or compensation for damages.
- 7. Having no property including a property shared with someone.
- 8. Not belong to any criminal organizations and having no family members who belong to any criminal organizations. *Organized Crime Exclusion Ordinances Article 2 (6).

☆A Single-Person Household

Some city-run apartments can be rented by a single-person household. (Please refer to a list of city-run apartments.)

If an applicant is a single-person household, one of the following conditions must be met instead of No. 3 of the eligibility criteria.

(Available only for those who can live alone or can receive constant long-term care.)

- (A) An applicant is older than 60 years old
- (B) An applicant with disabilities designated under Basic Act for Persons with Disabilities Article 2.
- ①A holder of a disability grade 1 to 4 handbook.
- ②A holder of a mental disability welfare handbook.
- ③A holder of a special education handbook.
- (C) An applicant with the wounded and sick veteran handbook.
 Note that only certain levels of disability on the wounded and sick veteran handbook are eligible for affordable housing.
- (D) An applicant formally recognized as an atomic bomb survivor by the Japanese Ministry of Health, Labor and Welfare under the Atomic Bomb Survivors' Assistance Act, Article 11 (1).
- (E) An applicant living under the Livelihood Protection Law, Article 6 (1) or receiving benefits under the Act on Measures on Expediting of Smooth Return of Remaining Japanese in China and for Assistance in Self-Support after Permanent Return to Japan, Article 14 (1).
- (F) An applicant is a repatriate from abroad, and it has been no longer than 5 years since he/she returned to Japan.
- (G) An applicant receives compensation payments related to a leper colony under the Act on Payment of Compensation to Inmates of Hansen's Disease Sanatorium
- (H) An applicant is recognized as a victim of abuse by a spouse under the Act on the Prevention of Spousal Violence and the Protection of Victims, Article 1 (2), and one of the following conditions is applicable to the applicant.
- ① Must be less than 5 years since an applicant last got temporary protection from abuse under the Act on the Prevention of Spousal Violence and the Protection of Victims, Article 3, 3-3 or Article 5.
- 2 Must be less than 5 years since a protection order went into effect after an applicant had filed a petition for protection of a protection order under the Act on the Prevention of Spousal Violence and the Protection of Victims, Article 10 (1).

★Elder Persons Applying for Affordable Housing

- ★The elderly who meet one of the following conditions can apply for affordable housing in Hikone.
 - (1) An applicant meets one of the conditions (B), (C), (B), (F), or (G) specified in the previous page.
 - (2) An applicant must be older than 60 years old, anyone who is moving in with the applicant must be older than 60 years old or younger than 18 years old at the time of the end of an application period.
 - (3) Anyone who is going to live together with an applicant is younger than elementary school age.

★Required Documents

- 1. Application Form for a City-Run Apartment *designated form
- 2. A Certificate of Residence
- 3. Income Report Form *designated form
- 4. An Income Certificate Certifying the Annual Income of An Applicant and Those Who Will Be Moving In.

- 5. Tax Payment Certificate to Prove that You Have No Balance for Local Taxes (resident tax, Keicar tax, property tax, etc.)

- 8. Koseki Tohon (certificate of family register) or other documents are required to submit accordingly.

☆ Requirements for Single-Household Applicants

The following documents are required single-household applicants who want to apply for affordable housing to submit along with an application form, etc.

- 1. Jikatsu Moshitate Sho
- 2. One of the following requirements according to the eligibility criteria for single-household applicants listed on page 2.
 - A photocopy of a physical disability handbook, mental disability welfare handbook, or special education handbook.
 - A photocopy of a wounded and sick veteran handbook
 - A special benefit certificate
 - A certificate issued by a head of a welfare office
 - A certificate issued by a prefectural welfare bureau
 - A notice regarding the amount of compensation payments for victims of a leper colony or a certificate related to a leper colony.

☆Cautions When Applying for Affordable Housing

- 1. At the same time submitting an application form and other requirements, the initial screening will be conducted. For this reason, an applicant him/herself or a person who will be moving in together needs to come to a customer service desk of the relevant division.
- 2. Applications submitted by mail or outside of opening hours of the city hall are not accepted.
- 3. One application per household only is accepted.
- 4. Only an application that meets all eligibility criteria is accepted.
- 5. If there's any error in your application form or/and required documents, your application won't be accepted.
- 6. If there is any attempt to make a false application found during the eligibility screening, your application will be immediately rejected.
- 7. Even after your application is approved, if false information is found in your application, your eligibility for affordable housing will be stripped.
- 8. If you apply for affordable housing and get approved on the condition that you and a engaged person are going to get married by the certain date, if you fail to do so, your rental agreement will end immediately.
- 9. The income threshold or deduction amount may be adjusted in accordance with amendments in laws, etc.

★ How Applications Are Screened

- 1. The initial screening upon filing an application
- 2. The second screening after an application period is closed.
- 3. The third screening
- 4. The final screening by the Hikoneshi Eijutaku Unei Iinkai
 - (1) By taking the financial situation of each applicant into consideration, the Hikoneshi Eijutaku Unei Iinkai determines who is eligible for affordable housing or not.
 - (2) In cases where the number of eligible applicants exceeds that of available city-run apartments, who gets approved to rent an apartment will be selected by lot.

★ Move-in Procedures

- 1. Once you become an eligible tenant, you must complete the following procedures by a certain due date.
 - (1) A security deposit (equal to three months' rent) needs to be paid up front.
 - (2) A rental guarantor form has to be filled out by **two different guarantors**.
 - *In addition to the rental guarantor form, two guarantors' *Inkan* registration certificates, income certificates, and tax payment certificates are required.
 - *Both guarantors must be residents of Hikone.
- 2. Once every procedure is done, eligible tenants need to move in to a city-run apartment within two weeks and to submit a copy of their residence with a new address.

☆ Notes After Moving in to a City-Run Apartment

- 1. All tenants of city-run apartments must follow the rules established under Hikoneshi Eijutakuno Secchi Oyobi Kanrini Kansuru Jorei and Doujourei Shikou Kisoku and directions given by a landlord/landlady.
- 2. While some city-run apartments have parking spaces available for rent, other city-run apartments do not. If you want to use a parking space, you will be charged for use of a parking space separately from your apartment rent.
- 3. You are required to report your income in August of each year. Base on this annual income report, your monthly rent for the next fiscal is calculated and determined. If annual income exceeds the income threshold that qualifies an applicant for affordable housing, you may be required to vacate an apartment.
- 4. Even if one of the following happens, you will be ordered to vacate your apartment.
 - (1)An application is found to be fraudulent.
 - (2)Behind on rent for longer than three months.
 - (3) Damage an apartment, communal spaces, etc. intentionally.
 - (4) Not occupied for more than 15 days for no legitimate reasons.
 - (5) Subletting an apartment to someone else, and give tenant eligibility to someone.
 - (6)Using an apartment for any purposes other than a residence.
 - (7)Renovating or expanding an apartment with no permission.
 - (8) Changing or replacing an apartment lock with no permission.
 - (9) Violation is found during the renewal process.
 - (10)A renter or any tenant is found to belong to a criminal organization under the Act on Prevention of Unjust Acts by Organized Crime Group Members, Article 2 (6).
- 5. Refrain from causing trouble with other apartment residents and neighbors by having dogs, cats, or other pets. In cases where you repeatedly caused problems to others despite warnings, you would be ordered to vacate your apartment.
- 6. You will be charged for maintenance fees for communal spaces (lights, meeting room, etc.) accordingly.
- 7. Respect and cooperate with other apartment residents and neighbors in the same community to maintain wholesome and cultured living. You are also encouraged to join a neighbors' accusation and participate in community activities.

☆Income Threshold

The purpose of affordable housing is to offer financial help to low-income families, and therefore, monthly income threshold is set for whom qualifies for affordable housing. To calculate an applicant's monthly income, the combined annual income of all members who will be living together with and any dependents of an applicant's is needed.

☆Calculation of Monthly Income

Income means the amount of money earned excluding nontaxable income, and net income defines as the gross income minus taxes and other essential expenses.

- I. In cases where more than one person with earnings, income of all members will be calculated and combined.
- II. The following are considered nontaxable income.

Livelihood Protection payments, unemployment insurance benefits, workers accident insurance benefits, bereaved family pension, remittance, etc.

III. If an applicant or anyone who will be moving in together holds a current job for less than one year, use the equation below to calculate an estimate of annual income.

★How to Calculate Monthly Income

Monthly Income = (Total Annual Income − Untaxable Income) ÷ 12 months
