Eligibility Confirmation Notice: Supplemental Cash Benefit for Shortfalls in the Flat-Rate Tax Cut

This supplemental cash benefit is provided to qualifying taxpayers, based on their total income and tax cut information for fiscal year 2024, in order to address shortfalls in the initial Flat-Rate Tax Deduction program.

To receive the benefit payment, please complete the separate confirmation form marked “B2” and submit it, along with photocopies of your bankbook and/or bank card and identification, **by Friday, October 31, 2025, at 4:45 PM. Your submission must be delivered to the relevant division of Hikone City Hall by the deadline.**

Please note that if your submission is not received by the stated deadline, you will be automatically considered to have withdrawn from this cash benefit program.
