Mailing of the Application Form for the Supplemental Benefit for Shortfalls in the Flat-Rate Tax Cut

This supplemental cash benefit is provided to qualifying taxpayers, based on their total income and tax cut information for fiscal year 2024, in order to address shortfalls in the initial Flat-Rate Tax Deduction program.

Receiving this notice and application form means that you "may" qualify for this supplemental cash benefit. Therefore, please read the eligibility criteria, complete the application form marked "C2", and submit it along with other required documents, such as proof of bank account, proof of identification, a tax certificate for fiscal year 2024 (not the current year, and required only if your current address is different from the one as of January 1, 2024.) Please note that the application deadline is October 31 (Fri), 2025 at 4:45 PM, and your submission must be delivered to the relevant division of Hikone City Hall by the deadline.

You will be automatically considered withdrawn if you fail to submit your application by the deadline. Please give yourself enough time to submit your application for this cash benefit program.

Payment Date	Approximately one month after approval of your C2 form and other required documents. The benefit payment will be made on one of the following scheduled dates. September 4 (Thu), September 12 (Fri), September 19 (Fri), October 2 (Thu), October 16 (Thu), October 30 (Thu), November 14 (Fri), November 28 (Fri)

* No notice regarding the completion of your benefit payment will be mailed. Please check your bank account to confirm whether the above amount has been deposited after the payment date.

[Who May Qualify for This Cash Benefit Program]

Individuals who moved to Hikone City from another municipality or from abroad during 2024, and who had a registered address in the city as of January 1, 2025, may qualify if the eligibility criteria described on the "C2" form apply to them.

① The Total Income for 2024 Changed Significantly Compared to That of 2023.

- Your total income for 2024 is significantly lower than in 2023 (e.g., due to poor business performance or retirement).
- No income in 2023, but earned income in 2024 (e.g., those who graduated and joined the workforce).

② The Number of Dependents Increased during 2024

- Due to a baby was born, etc.

* The amount of tax deduction under the initial flat-rate tax cut program applied to your individual resident tax was determined as of December 31, 2023. Therefore, no change will be made to the amount of tax deduction even the number of dependents changed during 2024.

* Those who received the benefit payment by providing misleading or fraudulent information are required to return the funds to the city at once. Please also be advised that individuals who commit benefit fraud may be held legally accountable for their actions."

[Required Documents]

Please submit all the following documents by post.

- (A) Application From for the Supplemental Benefit for Shortfalls in the Flat-Rate Tax Cut [From C2]
- (B) Proof of Bank Account (A Photocopy)
- (C) Proof of Identification (A Photocopy)
- (D) Tax certificate for FY2024 (based on 2023 income), only if your address changed since January 1, 2024. Not the latest one for FY2025.

* If you wish to use a bank account not in your name, or appoint someone as your proxy to apply for or receive the benefit, you must submit a power of attorney. For details, please contact the Hikone Call Center at the number below.
