## About Cash Handout Program for Households Subject to Fiscal 2023 *Kintowari* Resident Tax (100,000 yen per household)

To households that are subject to fiscal 2023 *Kintowari* (per capita, 5,800 yen) resident tax, a handout payment is set to be provided as follows. If these eligible households have a child/children aged under 18 (to be precise, children born after April 2, 2005), 50,000 yen will be added per eligible child to a cash handout of 100,000 yen.

Having received this notice means that your household may qualify for the handout money. Therefore, please read the details given below and submit your application **by 2024, May 31 (Friday)** to the Hikone City Hall. Your application must be postmarked no later than 2024, May 31 (Friday).

### 1. Eligibility Criteria

Be sure to check whether your household must meet ALL THE FOLLOWING CONDITIONS.

- Households that were registered in Hikone City as of December 1, 2023.
- All household members are not subject to fiscal 2023 *Shotokuwari* resident tax.  
\**Shotokuwari* is a tax levied on every liable tax payer based on their previous year's total income, which is different from *Kintowari*.
- Households where all household members are not a dependent of someone who is subject to resident tax.
- Households where none of household members are a beneficiary of tax exemption under the tax treaty.

\*Caution!: For example, a university student who is living alone and exempt from resident tax but is a dependent of their parents who are subject to resident tax and parents living away from their child but are a dependent of their child are not eligible.

### 2. Important Points Upon Filling Out The Form

- Be sure to check all the required boxes on the form regarding your household members' tax statuses, etc.
- Only after reading and fully agreeing to all the conditions listed in "3. Consent", leave a check mark.
- Please refer to the step-by-step instructions for how to fill out the form.

### 3. Cash Handout Amount

100,000 yen per qualifying household \*One-time cash handout

### 4. Requirements

Please enclose the following documents in the return envelope

- Application Form (it must be completed)
- Photocopy of a bankbook
- Photocopy of a householder's photo identification
- Certificate of fiscal 2023 resident tax

[If you want to appoint someone as a power of attorney, make sure to submit the following documents as well.]

- Photocopy of a proxy's photo identification
- Proof of relationship between a householder and a proxy

\*If a proxy is a member from the same household as a householder, no need to provide proof of relationship.

### 5. Application Due Date

**2024 May 31 (Fri) \*Your application must not be postmarked no later than the due date.**
