

Cash Handout Program (100,000 yen per qualifying household) For Households That Are Subject To Fiscal 2023 *Kintowari* (Per-Capita, 5,800 Yen) Resident Tax

A cash handout of 100,000 yen per household is scheduled to be distributed to eligible households whose home addresses were registered in Hikone City as of December 1, 2023. Please note that this handout payment will be provided only to households that are subject to fiscal 2023 *Kintowari* (per-capita, 5,800 yen) resident tax and can meet criteria specified below.

*Households that are exempt from fiscal 2023 resident tax are NOT included this time.

*No handout payment will be provided to any household where all household members are financially dependent on someone who is subject to resident tax.

1. Households subject to fiscal 2023 *Kintowari* (per-capita, 5,800 yen) resident tax

How To Determine Whether You Need To Apply Or Not

A notice letter, application form, etc. regarding this cash handout program will be mailed out to qualifying households around late March.

If You Receive Only The Notice:

(Those who linked their bank accounts to their My Number cards before.)

If You Receive A Confirmation Form Or Application Form:

No Need To Apply.

- Unless you want to register a different bank account or renounce your handout eligibility, **there is no need to apply.**
- The due date for registering a new bank account or renouncing your eligibility is April 10 (Wed), 2024.
- The estimated timeline for the distribution of handout payments to eligible households is late April. For those who have registered a new bank account, it is estimated to be around late May.

You Must Apply.

Due Date: May 31 (Fri), 2024

*It must be postmarked no later than the due date.

- **Be sure to complete either form** to receive your handout payment.
- It takes more or less a month to receive your handout payment after your application is accepted.

50,000-Yen Cash Handout Program For Low-Income Households With Children (50,000 Yen Per Child Provided To Qualifying Low-Income Families)

[Eligibility Criteria]

Households That Resided In Hikone As Of 2023, December 1 And Can Meet The Conditions Listed Below.

- **Households that resided in Hikone as of 2023, December 1 and where all members are exempt from fiscal 2023 resident tax or are subject to fiscal 2023 *Kintowari* (5,800 yen, per-capita) resident tax.**
 - *The amount of fiscal 2023 resident tax is calculated based on annual income earned from January to December 2022.
 - *Households where all members are a dependent of someone who is subject to fiscal 2023 resident tax do not qualify.
- **Households with children who were born after April 2, 2005.**
 - *Please note that a cash handout of 50,000 yen is provided Per Child, and low-income households with eligible children must have resided in Hikone as of December 1, 2023.

[If your household can meet either condition below, please contact the call center to confirm eligibility.]

- Babies born between December 1, 2023 and April 1, 2024
- Having a child/children who is/are living separately but finically your dependent.
 - *In this case, you must prove and claim your child/children as a dependent.

[Children under the following circumstance are not included.]

- Children in foster care are not eligible regardless of whether or not their biological parents are tax-exempt.

Be careful that eligibility criteria stipulated in “The One-Off Cash Handout (50,000 yen per child) Program For Families With Children” previously differ from the ones stipulated in this cash handout program.

If the bank account details of the head of eligible household have already been registered with the city:

There Is No Need To Apply.

*Once the handout payment is paid into the registered bank account, a payment notice will be mailed around late April.

If your household qualifies for this cash handout program, but the city does not have bank account details:

A Confirmation Or Application Form Will Be Mailed Out To The Address Of Your Household.

*Ensure to fill in all the required information on either form, and submit it with a requirement(s) by post. It takes more or less one month to receive the handout payment provided that your application has no issues.

Your handout payment under this program is scheduled to be paid into the same bank account as registered for the 70,000-yen cash handout program for inflation or the cash handout program (100,000 yen per qualifying household) for households that are subject to fiscal 2023 *Kintowari* (per-capita, 5,800 yen) resident tax.
