☆Welfare Medical Subsidy System in Hikone

A welfare medical subsidy system is the system to improvement of preservation of health and increase of welfare of a Hikone citizen for the object and help the part of the personal payment or everything when being treated by a doctor by health insurance. Please see the following about each subsidy system.

★Elderly(65-74 years old) From August 2014, self-pay rate and the target age has changed.

A mentally and physically handicapped person

The person who receive a grant of Shintai Shogaisha Techo (Certificate of the physically Disabled) 4 kyuu, Ryoiku Techo (Rehabilitation Certificate) B1.

Living alone elderly widow

Once in the mother or fatherless families, people living alone in the state has continued for more than one year.

2Single-parent home

Eligible person: Mother-to-child families are dependents under the age of 18 a child, motherless family

③Living alone widow

Eligible person :Once in the mother or fatherless families, people living alone in the state has continued for more than a year (less than 65 years of age).

(1)(2)(3)Self-pay in health insurance:

*Each of oneself ,spouse and a maintenance person having duty pays resident tax becomes 500 yen for 1 medical fee specification.

(hospitalization) 1000 yen for 1 day but every 1 medical agency, 14000 yen for 1 month, the limit.

(Preparations) there is no self-contribution.

Help of the psychiatry going to hospital medical expenses

Eligible person:Mentally disturbed person preservation of health welfare pocket diary first kyuu or second kyuu is possessed, and independent support medical care.

That the independent support medical expenses(spirit going to medical care) pay their own fees.





☆Register or Cancel Registrations of Vehicles

Owners of regular cars, small engine cars and motorcycles are subject to the car tax. The tax for the fiscal year of 2015 will be payable by the owners as of April 1, 2015. If you no longer use your registered car or if you have transferred it to another person, please report it to the appropriate office by April 1, 2015. The disused car is to be reported within 30 days and the change of a titular is to be reported within 15 days. Inquiries:

☆Delayed Payment Plan: National Pension

I All citizens aged 20 to 60 including foreign residents should join the National Pension System and pay the premiums. If you have not paid the premiums for 40 years you cannot get the full amount.

In case you forgot to pay for some period of time you, between 60 years old and 65 years old, can pay and fulfill the period, then you can get pension closer to the full amount..

In order to receive a senior citizen's pension you should have paid the premiums for 25 years and more, including exemption period; if you have not paid for at least 25 years you can join the National Pension System and pay the premium by the time when you become 70 years old (limited to the people who were born on April 1, 1965 or before).

Those of Japanese nationalities who currently live in foreign countries can join this system, too.


- II You can pay your unpaid premium of the National Pension belatedly from October 2012 to September 2015. Please apply to Japan Pension Service, Hikone Office (*Hikonr Nenkin Jimusho*). If you pay the unpaid premium back within ten years, you will be entitled to receive the national pension or the pension extra.
 - When you pay the unpaid premium within three years, additional money will be added.
 - This plan is not intended for those who receive the senior citizen's pension.

☆Information from the Sanitation Center

<u>(1)Direct Drop-Off of Oversized Trash to the Center</u>

The Center will be carrying out a special collection of oversized household trash on March 22 (Sun) $9:00 \sim 12:00$.



- *Drop-off of oversized trash is charged. (*free of charge for a small electrical appliance of shorter than 1m.)
- *Recyclable household appliances (TV, air conditioner, refrigerator, washing machine and clothes dryer) are not oversized garbage. Those are not acceptable at the Sanitation Center by law. Please ask the Center or electrical appliances store about collection details.

Personal computers are also recyclable. Please consult with the item's manufacturer about collection details.

- *Dropping-off trash is allowed only during the designated time
- *The Center accepts direct drop-off of your garbage Monday through Friday (except Holidays) 9:00 ~ 12:15, 13:00 ~16:15
- <u>②The new fiscal year's garbage collection calendar</u> will be distributed with the March 1 issues of *Koho* HIKONE in Japanese. Please keep it for one year. The calendar in English will be available at the City Sanitation Center or the Living Environment Division, City Hall 1F. Please be ready to give your address at the window, because the collection schedule is different for each school district. The calendar (in Japanese) will appear on the Hikone City website in late-March also.
- <u>③Need a consultation with the Center and submit the registration about new garbage collection place</u> before your community change your community's collection place.

☆Be Sure to Report your Taxes

Deadline

Final tax returns

Please report your tax return as soon as possible since the office will be crowded as the deadline draws near. You can send it by mail. If you want to consult about the report of consumption tax, please bring a copy of the report on final accounts and an itemized statement of income and expenditure. Even if the report of final tax return of income tax and reconstruction special income tax is unnecessary, a person who does not report addition of deduction from income, and a dependents relatives might need report Municipal tax and tax on the residents of prefecture.

The eligibility of a spouse deduction and an allowance for dependents:

- *The sum total of income is less than 390,000 yen in the end of 2014 or at the time of the death.
- *The person who is eligibility for deduction does not duplicate.
 - ►Income tax, reconstruction special income tax and donation tax: March 16(Mon)
 - ► Municipal tax and tax on the residents of prefecture: March 16 (Mon)
 - ► Consumption tax and local consumption tax of personal business: March 31 (Tue)

Tax payment

Be sure to pay your taxes within the period. When the deadline is over, you might have to pay 9.1% a year of taxes in arrears. (2 months from the next day of deadline:2.8%)

- ▶Income tax, reconstruction special income tax and donation tax: March 16 (Mon)
- ► Consumption tax and local consumption tax of personal business: March 31 (Tue)

We recommend you to use an automatic transfer system at a banking facility.



☆How about Taking a Bus to School? For only High School students

What is your best way to go to school? Commuting by bike or on foot might increase the risk of traffic accidents. It also applies to a car your family drives. ☆Habitual Abortion More than 80 %can be Cured.

Habitual abortion means more than two times of miscarriage, or several times of neonatal death (less than one week).

A half of the cases of habitual abortion are coincidental miscarriage due to the chromosome aberration of fetus; patients don't need any treatment. Another half of the cases have each causes.

A woman who already has a child and repeats miscarriage need a check and cure.

It is possible for more than 80% of women suffering from habitual abortion (including coincidental miscarriage) to have another baby.

The Health Promotion Division provides detail information about habitual abortion with a homepage, and public-health nurses give counsel.

Support of artificial insemination expenses

Eligibility (Those who meet all of the following)

- OHusband and wife who live in the city at the time of a medical treatment and application, and are legally married.
- Husband and wife's income in the last financial year is less than 7.300,000 ven.
- OHusband and wife who are not behind with municipal tax.

The amount of support: Half of the amount of the charge is supported.

For a total of two-years, the amount of money is 50,000 yen.

Time limit: March 31 Tuesday 2015

When you get the treatment in March, you can apply until April 30 Thursday 2015.

Support of specific infertility treatment expenses

Eligibility (Those who meet all of the following)

- OHusband and wife who live in the city at the time of a medical treatment and application, and are legally married.
- Those who have received Shiga specific infertility treatment expense support
- OHusband and wife are not behind with municipal tax.

The amount of support: Specific infertility treatment expenses is supported.

The 1st year is for 3 times, after the 2nd year it is for 2 times. The support can be applied a maximum of 10 times within 5 years. Those who apply to the support first time after April 1 2014 is not limited the times of a year when wife is under 40 years at the first treatment.

The support can be applied maximum of 6 times.

In the following cases, 25,000 should be supported.

*embryo transplantation by using frozen embryo

*When treatment is stopped because patients cannot get egg in spite of ovulating.

★Application limit: within 3months from the date of Shiga prefecture decision
