☆Prefectural&Municipal Tax and Special Income Tax for Reconstruction and Income Tax Return

It is expected that the counter will be very crowded around these dates so please go as soon as possible.

≪Prefectural & Municipal Tax ≫ February 16(Tue)~March 15(Tue)

Those who are to file a prefectural and municipal tax return will receive "documents for declaration". You can get the return form at the following venue and you can complete the procedure there. If you need the form in advance, please ask for it at the Tax Division (City Hall 2F). If you file an income tax return, you do not have to file a prefectural and municipal tax return.

Things required for filing:

"documents for declaration", Your seal (HANKO), documents proving the income in 2015, income-and-outgoing detailed statement, documents of deductions from income, documents proving your spouse's income(Those who receive a tax reduction for spouses), booklet for the challenged people (challenged people)

You can file a simplified tax return (final return for national pension etc.)

When you are in following categories, please file at Hikone Chamber of Commerce and Industry 4F.

- *Those who receive a special reduction of housing loan.
- *Those who have transferred income.
- *Those who report a blue return.
- *Those who report a business income for the first time.
- *Those who receive a statement from tax office.
- *Those who receive a special reduction of housing for seismic reinforcement, barrier free and energy saving.

Attention:

A certificate is required when you receive deduction of national pension insurance.

The specification of medical expenses is required when receiving deduction for medical expenses.

You do not have to file an income tax return if you get a public pension that is 4,000,000 yen or below and your income with other than public pension is 200,000 yen or below.

Please file a final return if;

- 1. You have the self-assessed part of the personal income tax when you have a business income or an income from immovable.
- 2. You have an employment income and;
 - ① Your total amount of earnings from employment income exceed \$20,000,000.
 - ② You received a salary from one source only, and your total amount of various types' income (excluding employment income and retirement income) exceeded ¥200,000.
 - ③ You receive employment income from two or more sources, and the total amount of earnings from employment isn't subject to the year-end adjustment or withholding tax and various types' income (excluding employment income and retirement income) exceed \(\frac{\cute2}{2}\)00,000.



☆Revision of the City, Citizen of the Prefecture Tax Comes into Effect in 2016

Revise of the system of special collection from public pension.

① Continution of special collection in case of moving-out or the change of the amount of tax.

The system of special collection is continued under the certain conditions, effected on October 1st. Please call us for more information.



In this revision, it is clear that the amount of tentative tax collection (for April, June, and August) is equivalent to the amount of one-sixth tax collection in previous year. This leads to level regular tax collection and tentative tax collection.

Revision of the system not requiring final income tax return for public pension.

Pension paid abroad is not apply the system which is not require final income tax return after 2015.

Extention of the application period for the special deduction such as housing dept loan

The application period for the special deduction such as housing dept loan is extended to June 30, 2019.

☆Some Senior Citizens can get a Deduction for Challenged People

You can make a deduction for challenged people against income tax or prefectural/municipal tax if you are approved by the Welfare Office that you meet the following three conditions, even if you don't have the "Identification Booklet for the physically challenged" or "Identification Booklet for the Intellectually Challenged" or "Identification Booklet for the Mentally Challenged".

Requirements of qualification

- 1 Those who are 65 years old or over and have a residence in Hikone city
- 2 Those who qualify for Nursing -Care Insurance

Those who have medium level or worse condition of dementia or need a help in everyday life.

Application: Please bring one's own Certificate of Insured Person of Public Nursing-Care Insurance and the *inkan of* the applicant (oneself or the family) to the Senior Welfare Division.

The result will be given in about ten days.

Vaccination of Pneumococcal Disease for the Elderly

This vaccination will be finish on Thurs. March 31 for the fiscal year 2015. If you do not receive the vaccination at the recommended ages, you will have to pay for it individually.

 \times Elderly people (over 65 years old) be able to have the vaccination one time by the public money furtherance at the recommended age. (between Oct. 2014 \sim the fiscal year 2018)

Qualification for the fiscal year 2015:

People aged 65, 70, 75, 80, 85, 90, 95, 100. (from April 2, 2015 to April 1, 2016)

②People aged $60\sim64$ who have defect on heart, kidney or respiratory, or who have defect on a function of immunity by human immunodeficiency virus.

*Hikone City already sent the questionnaire sheets to receive the vaccination to the eligible people on last April. If you haven't had 23 values Streptococcus pneumonia vaccination and want to have it, please receive it early. Those who lost the questionnaire or become residents of Hikone City after last April, please ask the City Health Promotion Division.
