# ★National Pension Premium for 2018 was Revised to ¥ 16,340 a Month

From April, 2018 to March, 2019, the National Pension Premium is to be \(\frac{1}{4}\) 16,340 a month. (Until March this year it was \(\frac{1}{4}\) 16,490 a month) You can get a discount by advance payment in cash. The deadline is Monday, May 1.

- ►Advanced payment for two years: ¥ 378,580 (¥14,420 discount)
- ► Advance payment for a year: ¥ 192,600 (¥ 3,480 discount)
- ► Advance payment for half a year: ¥97,240 (¥ 800 discount)

In Japan, all citizens aged 20 to 60, including foreign residents, should join the National Pension system and pay the premium. Also, in the following cases, you have to report to Hikone *Nenkin-jimusho* the City *Hoken Nenkin-ka* or its branches. Be careful if you fail to report, you may receive a lower amount of pension or sometimes you may not have your pension.

- ▶When you become 20 years old. (Procedure is accepted from the day before your birthday.) 2nd number insured person is excluded.
- ▶When you quit working. If you have a dependent spouse, you have to report for the spouse, too.
- ►When you are no longer a dependent family member of 2<sup>nd</sup> number insured person. For example, if you get a larger income or if you become divorced.

## **◆**Payment of additional pension insurance premiums

If you add 400yen and pay it, you can receive a lot of money than normal in a future.

If you want to apply, please make a procedure at Hikone *Nenkin-jimusho* or Nation Health Insurance office or Pension Division or branch offices.

#### **Important point**

- ► A member of Farmers' Pension must pay an additional pension insurance premiums
- ▶ A member of National Pension Fund can not pay an additional pension insurance premiums

#### **♦** There are three kinds of insured persons in the National Pension system.

- ▶1st number insured person: a citizen aged 20 to 60 who lives in japan such as a self-employed business owner, an agriculturist, a fisher, a student and so on.
- ▶2nd number insured person: a member of the social security pension for office workers or civil servant and is younger than 65 years old.
- $\triangleright$  3<sup>rd</sup> number insured person: the spouse who is a dependent on the 2<sup>nd</sup> number insured person and is aged 20 to 60.

# **★Expand The Outpatient Targeted Age in Child Medical Support System**

The outpatient targeted age was expanded from preschool student to the third grade student in elementary school effected in April (until March 31 after reaching age of 9) To receive this subsidy, you need the certification of welfare medical expenses receipts ticket (child medical care) We send welfare medical expenses receipts ticket on April 1 to those who submit the application forms. Please apply the form if you have not applied yet. Please contact us for further information.

- \* When you see a doctor in medical institutions in Shiga prefecture after April 1, please show them welfare medical expenses receipts tickets along with health insurance. When you take medical treatment in other prefectures, paying medical expenses not covered by medical insurance will be refunded you after you apply for it at municipal office.
- \* The subsidy for hospital changes is paid you back after applying for refund at municipal office as is conventionally done.

[Things you need to refund]

Receipt, a seal(hanko), a bankbook transferred into, health insurance certificate for the targeted person (Only the subsidy for hospital changes for the fourth grade elementary school student and older to the third grade junior high school student), a letter (only person concerned for expensive medical changes or others)

#### \*Notification of National Health Insurance Coverage and Information on Generic Drugs

Anyone who is covered under National Health Insurance (NHI) or Latter Stage Elderly Healthcare will receive a notification regarding your NHI coverage and available generic drugs. This notification is mailed with the aim to remind the insured of how much NHI covers your medical expenses in last four months and to promote the appropriate use of medical facilities.

Among all members of NHI and Latter Stage Elderly Healthcare, people who are regularly prescribed medication will be informed how much money you could save by switching brand-name drugs to generic drugs in the notification.

If you have private health insurances other than NHI or Employees' Health Insurance, please contact a private health insurance company for the information mentioned above.

Starting in April, the Rehabilitation Centre and Developmental Support Office are going to be combined into "the Support Centre for People with Disabilities", and it is scheduled to be opened. This new support centre offers the following services to help people with developmental disabilities to live without anxiety.

## Counselling Services Regarding Developmental Disabilities

We offer counselling services for general matters of developmental disabilities and child development.

#### · Counselling Services Regarding Speech Delay and Language Disorder

We counsel parents with a preschool child(ren) on concerns of their child(ren)'s speech, pronunciation, etc.

#### · Rehabilitation Classes (Asunaro Class)

Preschool children with developmental delay and their parents come to classes to encourage the children through plays and so on.

#### · Paediatric Rehabilitation and Parents Classes "Tsubomi"

Preschool children with developmental delay and their parents come to classes to encourage the children through plays and so on.

#### · Counselling Support Group "Mebae"

The group offers the planning of government services granted under the Child Welfare Act and consultation services.

#### · Venues for Seminars About Developmental Disabilities

The support centre is used to host seminars for civilians in the time of Developmental Disabilities Promotion Week (from April 2<sup>nd</sup> until 8<sup>th</sup>), etc. For more information, please get in touch with us at the number specified at the bottom.

#### Please learn more about developmental disabilities.

"Developmental disabilities" mean inborn uniqueness (personal traits) and individuals who have some degree of difficulty doing day-today tasks.

What causes developmental disabilities are still unknown, but it is said that dysfunction of brains is the main culprit; neither the way parents raise children nor lack of individual effort. Additionally, developmental disorders are not only confined to children. Characteristics of every development disorder are different in many ways, and for this reason, it is key to make a different support plan for each person with developmental disabilities.

#### **☆School Expense Subsidies System**

School expense subsidies are provided for families: Guardians who have financial difficulties. The subsidies are to be used for a part of lunch and school supplies.

Target: Those who have a Resident's Certificate in Hikone City and their children are attending municipal elementary school or guardians listed below.

- ► Those who are exempt from taxation or qualified for reduced taxation.
- ▶Those who are provided with "Allowance for Single Parents"(jido fuyo teate) not "Children's Allowance"(jido teate)
- ►If the guardian "Social Welfare/Livelihood Protection" is stopped or has expired.
- ▶Others: Those that the Board of Education admits are eligible for it.

Content: School subsidies, School lunch, School trip expenses, etc.

How to apply: The application form is available at each elementary school, junior high school and the Board of Education (Civic Center 2F) Please fill in the forms and apply for the subsidy at each school.

- \* For families who did not live in Hikone City as of January 1, 2018, the Income Certificate ( such as Tax Certificate of 2018 which shows the income of 2017) needs to be attached the application form.
- \* You can apply in the middle of the fiscal year, subsidies are provided monthly after the application is accepted.
- \* If You apply at school between the 16th and the end of the month, subsidies are provided from next month.

# Special Benefits for the Challenged and Benefits for Children with Disabilities

"Special Child Welfare Allowance" is granted to its eligible beneficiaries on a quarterly basis (April, August, December) and has the aim to promote the children's welfare. "Benefits for the Challenged" and "Benefits for Children with Disabilities" are granted to the eligible four times a year in the hopes of easing the financial burden.

#### · Amount of Benefits

Under the existing law, the amount of benefits is determined. Please refer to the table below.

#### · Who's Eligible?

**Special Child Welfare Allowance:** Parents or legal guardians who are taking care of a child under 20 years old with class 1 to 3 or class A to B1 disabilities <u>at home</u>. (No longer eligible to receive benefits once the challenged get accepted to a day-care facility for people with disabilities)

**Special Benefits for the Challenged:** Persons over 20 or older with severe cases of physical or mental disabilities, who are required constant care. (Not eligible for persons who stay in hospital for more than 3 months or who are taken care of at a daycare facility.)

**Benefits for Children with Disabilities:** Persons under 20 or younger with severe cases of physical or mental disabilities, who are required contact care. (Not eligible for persons who stay in hospital for more than 3 months or who are taken care of at a daycare facility.)

\*Note: When there are any changes in disability levels written in one's disability handbook, please check which benefits a person with disabilities are eligible for or not.

#### How to Apply for the Benefits

Please file either a medical certificate or disability handbook and required documents of an applicant's to the Challenged People's Welfare Division. All required documents are available at the same division. After screening of all applications and documents, there is a chance you might not become eligible for any benefits. Therefore, please contact the division in charge at your earliest convenience.

#### Income Limitation

**Special Child Welfare Allowance:** Earnings of parents/guardians of a child with disabilities and all members living under the same household need to stay within the income bracket for the eligibility of Special Child Welfare Allowance

Special Benefits for the Challenged & Benefits for Children with Disabilities: Earnings of an applicant, person with obligations to support and spouse household need to stay within the income bracket for the eligibility of benefits.

# \*\*Registration and Prevention Injections Against Rabies for Your Dog

It is the owner's responsibility to register your dog and to get your dog injected. Be sure to get your dog injected once every year.

#### • Dogs that need this injection:

Any dog that is 91-days-old and over

• Charge: Registered dog Unregistered dog ¥3,400 ¥6,400

\*Disabled persons' aid dogs are exempt from the charge.

\*\*Please bring exact change.

#### "Important Notes before you bring your dog" · · ·

- 1) Bring the invitation postcard (fill out a questioning spaces) and your dog registration card with you
- 2) If you have an unregistered dog, bring a memo with the owner's name, address, phone number, the dog's name, kind, date of birth, and sex.
- 3) The dog must be accompanied by a person who is able to control it.
- 4) Please bathe the dog before coming to the Center.
- 5)If your dog can not get this injection at the designated place unfortunately, be sure to get it from a family veterinarian
- 6) Please clean up if your dog has a bowel movement.
- 7) Be sure to attach a leash to your dog's collar, unless it is a guide dog.
- ★Be sure to put a dog tag which proves a previous injection, on the collar
- ★When the owner changes their address or your dog has passed away, please notify it Consumer Affairs and Environment Division. You can download a notification form from Japanese Hikone Website.

#### **★Amount of Household Waste**

The amount of garbage produced by households in Hikone has been on the decline since 2013, and the average amount per person was recorded as 895 grams <u>per day</u> in 2016. Notwithstanding, the number is still higher as opposed to the one in other parts of Shiga Prefecture.

In light of this fact, this fiscal year, we looked into what types of garbage were commonly produced in the hope to latch on to the actual situation of waste management and food loss at home and to make the best use of the results for our waste reduction schemes.

When we categorized household waste into 12 different types, wet kitchen refuse accounted the most – 40%, followed by plastic and cardboard containers (empty snack boxes, etc.).

To dissect the result in more detail, we sorted the wet kitchen refuse out into six types and found out that cooking scraps, leftovers and expired food were responsible for 40% of the total amount. Throwing out leftovers and untouched food items that have passed expiration dates is a primary contributor to food loss.

The main takeaway from this probe is there are basically two types of household garbage – garbage can be reduced by proper disposal, like plastic containers, wrappers, etc., and "*Mottainai*" (wasteful) garbage comprises a great deal of food loss

Speaking of combustible waste, it can be cut down by means of proper waste disposal practices. For example, when you separate garbage, you can throw away plastic containers with food stains as combustibles, but if you just rinse the stains out of the containers, they can be recycled, thereby increasing the amount of recyclable resources. This is true of paper waste, such as magazines, and so on.

In order to curb the amount of waste, it is important to avoid overshopping and reduce leftovers. The way that each of us separates garage can lead to either increase or decrease in the amount of garbage, so please bear the aforementioned in mind when you dispose of household waste.

#### **★Checklist Before Signing a Contract**

The new fiscal year is the time for us, the Japanese, oftentimes to take a whack at something new such as lessons, sports clubs, and so on. It is important to think twice and take a good look at terms and conditions of contracts before signing up for any. Once you make a contract, in principle you are required to obey terms and conditions of the contract, and it is difficult to cancel the contract out of the blue. The checklists below will come in handy when you want to sign a new contract with a store, etc.

#### **Basic Checking Points**



☐ Are you sure what kind of services you will be given, or how many products you will purchase?
☐ Precisely how much will you be charged for the contract? Are there any additional fees you will have to pay for?
In the case of instalment payment, how much will the total amount of payment be?
☐ Are verbal explanations and promises you were given are clearly written in the contract?
☐ Are there clauses related to the contract? Are clauses in regard to fines and damages mentioned in the contract?
☐ In the case of online shopping, can you return products within a certain period of time?
If yes, what is the condition for returning purchases?
☐ Are a company's name, address, contact number and representative's name shown is the contract?
Checking Points for a Long-term Contract
☐ Does the contract allow you to cancel the contract halfway?
☐ Are any conditions on the cancellation of the contract specified?
☐ Have you checked terms and conditions regarding additional fees and how to fulfil the payment
upon the cancellation of the contract?

#### **★Protect Precious Trees from Forest Fires**

Spring is the time of the season when forest fires occur more frequently as opposed to other seasons. Fallen leaves pile up on the dry ground of mountains in the spring. The favourable conditions for possibility of forest fires are met with low precipitation, dry air and the monsoon. Making matters worse, it is believed that the number of forest fires rises as rice fields are deliberately put on fire; called stubble burning, and more and more people hike up mountains for trekking, edible wild plants, etc.



#### Many Cases of Forest Fires Are Caused by Human Errors.

Of all wild fires that occurred in 2017, the cause of 309 cases, accounting around 30%, was "bonfires". Cigarette ends and arson were also responsible for the forest fires recorded in 2017, which suggests that a lot of forest fires are man-made.

Six Key Measures to Prevent Forest Fires from Happening

- ① Do not start a bonfire at a place where dried leaves and tree twigs have piled up.
- ② Smoke cigarettes only at a designated smoking area, make sure to put out the smouldering fire of cigarettes and do not drop cigarette ends.
- ③ When you use a fire for a BBQ or other purposes, ensure to make a fire only at a designated area, and put out a fire completely.
- ④ As for personal garbage, either bring it back home or leave it at a designated garbage collection place.
- (5) When you need to use a fire, pay attention to soundings and keep water to extinguish a fire nearby.
- 6 When the air is dry or the wind is strong, do not start a bonfire or use a fire.

Forests are precious natural resources that absorb CO2 and supply oxygen invaluable for lives. Once trees are lost to fire, it takes the tremendous amount of time to recover. We can forestall forest fires with individual caution. In order to protect trees as well as lives and properties, please handle fire in a forest with extra caution.



# **★Natalia's Room (No.45)**



Have you thought what the Japanese will do when they want to make friends with more people? It appears that many of them opt to take part in club activities, start taking lessons or do some local volunteer activities. Joining activities like these of their own volition enables them to expand opportunities to meet and form a new friendship with complete strangers.

On the other hand, in Brazil, we are more likely to broaden existing bonds of friendship rather than make friends with others we have never met before from scratch, which I came to notice after coming to Japan.

The Japanese usually hang out with different groups of people from a school, workplace, home town, and so on. It appears to be common for them to mingle with those different groups of people separately as opposed to how we, Brazilians, normally hang out to see others. For instance, if there is an outing with school friends, Brazilians casually invite people who have never met any of those school friends before. It is also flat-out normal to give a shout to colleagues, friends, etc. that we are planning to have a party with the family, and of course, we ask a husband/wife to come to a get-together with friends or colleagues. In this way, we have a great many opportunities to get to know someone you would never meet otherwise. There is no doubt that Japanese people introduce friends to other friends too, especially on certain conditions, but nonetheless, it somewhat differs from our way since Brazilians do such a thing under no circumstances.

On top of it, there are regularly organized gatherings where people in common get together, such as "residents' association", "school reunions", to name a few. In actual fact, there are relatively few similar gatherings in Brazil. This, in a sense, alludes that the Japanese people cherish the collective consciousness by nature.

Given that the concept of social structures is distinct in many ways from country to country, because the way you communicate and etiquette you gained while growing up in foreign countries do not make sense to the Japanese, I assume that some foreign residents are missing out chances to get to know others. This is true of some Japanese people who failed to make friends overseas.

All in all, if you can become flexible with your attitude, it will come in handy to understand differences in how to meet people. We all need each other and cannot live without others, so it is always nice to see circles of friends become bigger and bigger.
